2020 "Raffle Basket" Restaurant Give Back Contest Rules October 2020

DETAILED CONTEST RULES

- This contest is sponsored by Hogs and Honeys Foundation for Kids, 2014 Old Arch Road, Suite 2062, East Norriton, PA 19401 (aka Hogs & Honeys)
- The contest starts on October 1, 2020 and ends on December 1, 2020 at 11:59PM.
- Participants enter the contest by doing the following:
 - Buy a meal or a product at a participating sponsor, obtain a dated receipt for the purchase showing the purchase during the contest period (\$10 minimum suggested)
 - 2. Get a 2020 Hogs & Honeys Restaurant Give Back card
 - 3. Three (3) valid receipts and three (3) cards is one (1) entry
 - a. Submit your entry it by e-mail, following steps b. and .c
 - b. take digital picture(s) of the 3 receipts and 3 cards that clearly show the details, this constitutes an "entry submission"
 - c. Email the entry submission and your contact information (Name/Address/Phone) to "prizes@hogsnhoneys.org"
- Participants can enter as many times as they wish, however each entry must be valid and contain 3 unique receipts that are not part of any other entry.
- Each entry is limited to one (1) receipt per participating sponsor per day. As an example: If you eat at Mel's Diner 3 times a day, you can't take yesterday's 3 receipts and submit them as one entry. HOWEVER, you can collect 3 days worth of receipts (9 total) and submit 3 separate entries, each using one Mel's Diner receipt from each day.

- Once a receipt has been submitted as part of an entry, it may not be included in any other entry by any person, with the exception of multi-person restaurant receipts:
 - 1. Multi-person restaurant receipts can be submitted, however only one purchase per submitter will be accepted as an entry.
 - 2. Each individual may submit their own valid entry, as long as their corresponding purchase is clearly identified in their submitted receipt picture.
- One entry per entrant per day, multi-entry e-mails will not be accepted. If you
 submit multiple entries in one day, the subsequent entry will not be accepted, but
 can be submitted on another day by the entrant.
- Participants can submit as many email entries as they wish, as long as the entries comply with the rules of this contest.
- How to receive one free entry:
 - Send a letter in the mail requesting a free entry to Hogs and Honeys

 - 2. Include valid contact information, it must include your name, mailing address, and your phone number.
 - 3. Limit: One free entry per person, entrant must meet all other eligibility requirements, and comply will all contest rules.
- Prize opportunity winners will be notified on a first come, first served order, based on the time that the valid entry submission is <u>received</u> by Hogs & Honey's "<u>prizes@hogsnhoneys.org</u>" account.

- Prizes will be awarded based on the order that opportunity winners reply to Hogs
 & Honeys e-mail notification with a prize selection. Opportunity winners will
 select from prizes available at the time, as published on www.hogsnhoneys.com
- Winners may provide a prioritized list of several prize selections, in order of preference to increase their chances of winning a prize they want. Only one prize will be awarded.
- There is no guarantee that any prize a winner selects will not have been awarded to a previous winner. If a prize is no longer available, an opportunity winner will be notified by e-mail to re-select based on available prizes, until they select an available prize or no prizes remain.
- The Top 5 submitters of valid entries (counted by number of valid entries submitted during the contest period) will be able to select from a group of "grand prize" items selected by Hogs & Honeys.
- You must be able to receive your prize at Hogs & Honeys Foundation For Kids location in East Norriton, PA during designated times, or other prize distribution locations in Montgomery County, PA as determined by Hogs & Honeys. No prizes will be mailed or delivered to winners.

 determined by Hogs & Honeys. Any prize unclaimed 3 weeks after it is awarded
 to a winner may result in the winner being disqualified for that prize. The
 winner's entry will still be valid as part of the grand prize portion of the contest.

 - 3. Entry does not contain images of 3 valid receipts. Entries with less than 3 receipts are not valid. Entries with more than 3 receipts are not valid.
 - 4. The entrant's email address and/or contact information are incorrect or malfunctioning, rendering the entrant unreachable.
 - 5. Entry submission information is illegible, unclear, undated, or appears to have been maliciously altered.

- Email entry submissions may only be submitted to the identified entry email address associated with this contest.
- Any entry attempt that is not received by the identified email address (for any reason), or through a valid "Free Entry" method is not considered a valid entry.
- The date and time of each e-mail entry is determined by the most recent email "Received" header line date and time, adjusted for local prevailing time in Montgomery County, PA.
- In the event of a tie, where multiple valid email entries have exactly the same "Received" header timestamp: Entries will be ordered by first calculating the elapsed time between each entry e-mail's first "Received" header and last "Received" header time stamp. The entry with the longest elapsed time will be ranked first among the tied entries, subsequent entries will be ranked in order down to the entry with the least elapsed time.
- Grand Prize tiebreaker: If there are multiple entrants that appear to qualify for the grand prize "top 5" based on having the same number of total entries, the tiebreaker will be awarded to the entrant who submitted all of their entries first.
- Free Entry requests will be processed in sequential order based on the day and time that the mail item is opened and recorded by Hogs and Honeys Foundation for Kids. Hogs & Honeys is an all volunteer organization, and makes no guarantees about timely processing of physical mail. Delivery of and access to physical mail may be interrupted by factors beyond Hogs & Honeys control.

fraudulent. Hogs & Honeys will disqualify any entry from entrants who do not meet the eligibility requirements and will also delete any online entry if it learns that it was submitted by anyone under the age of 13 in compliance with the Children's Online Privacy Protection Act.

- Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider, or other organization that is responsible by assigning email addresses or the domain associated with the submitted email address.
- Hogs & Honeys and sponsors are not responsible for technical, hardware, software or telephone or other transmission failures of any kind; lost or unavailable network connections; or incomplete, garbled or delayed computer transmissions whether caused by the organization, users, by any other equipment or programming utilized in promotions, games or contests, or by human error which may occur in the processing of submissions, which may limit an entrant's ability to participate.
